Ms. Gustafson requested that the Board consider how recommendations from IPN are worded. She further reminded the Board that the Board does not have the authority to "further evaluate nurses" and that the Board may only impose IPN on a nurse if they determine that the nurse is not safe to practice. A motion was made by Newman to add the language "that the person has to sign a contract with IPN if the nurse is diagnosed with a condition that would prevent the respondent from practicing nursing with reasonable skill and safety to patients" to the final order. Motion passed unanimously.

Mr. Baker also informed the Board that he was on a panel discussion regarding the Nurse Practitioner legislation this session. The board office has had multiple calls with NCSBN regarding the Nurse Licensure Compact implementation. Mr. Baker informed the Board that he expects The Compact to go into effect as early as next summer due to the number of states currently in The Compact. Mr. Baker will go to Chicago November 15th to meet with the Executive Directors of the ten states which have already passed the new compact. The Board was reminded that the next edition of the Florida Nursing Quarterly comes out later in October. Ms. Sutton-Johnson will be attending a NCSBN committee on October 17-18 regarding marijuana regulatory guidelines. Mr. Baker thanked the staff for their continuous hard work and the Board for being at the meeting for October in light of Hurricane Matthew. Staff are still currently working on obtaining locations for the 2017 board meetings, but Mr. Baker will inform the board as soon as it is known where locations will be.
